

- For the visits related to advice & consultancy, travel and other expenses of UICT Faculty & Staff shall be reimbursed by R.L.College on mutually agreed terms.
- . The faculty members and students of R.L.College can use the library facility of UICT for short-time.
- Usage of UICT academic infrastructure can be allowed for limited period subject to its availability, approval of Head of the facility/department and Institute norms.
- Both institutes agree to help, identify and invite the faculty members and researchers from the other institutes to participate in conferences, workshops and short-term courses.
- This MOU may be amended, renewed and terminated by mutual written agreement of the institutes at any time.
- Either Institute shall have the right to terminate this MOU upon 60 days prior written notice to the other Institute.

5. Confidentiality

- The UICT and the R. L. College agree to hold in confidence all information/data designated by the institutes as being confidential which is obtained from either institute or created during the performance of the MOU and will not disclose the same to any third party without written consent of the other institute.
- The above confidential clause under this MOU excludes the information/data possessed by either institute before entering into this MOU or independently developed and/or information already available through public domain.

6. Duration of MOU

This MOU, unless extended by mutual written consent of the institutes, shall expire in FIVE years after the effective date specified in the opening paragraph. However, on review, the MOU shall be extended for another TWO years by mutual consent.

7. Coordinators

Both Institutes will designate persons who will have responsibility for co-ordination and implementation of this agreement.

8. Intellectual Property Rights

The intellectual property rights (IPR) that arise as a result of joint research and collaborative activity under the agreement will be worked out on a case to case basis and will be consistent with officially laid down IPR policies of the two institutes.

Conference here means the (1) International Young Scientist Congress (IYSC) which is held each year on 8 and 9 May, (2) International Science Congress (ISC) held each year on 8 and 9 December.

II. SCOPE:

Scientific information continues to have reference value over time. The digitization of such information serves important societal, cultural, scientific and technological developmental goals, including the preservation of scientific effort. It is the aim of the memorandum to strengthen co-operation between If Party and publication service provider (ISCA) to facilitate the end users in all the fields of research with a view to enhance international communication among researchers.

RESPONSIBILITIES OF ISCA:

- a. For Publication
- I. ISCA will publish the material like proceedings, souvenir, research papers special issue of the journal etc. through proper process- of publication for which II Party has given the right. It will cover only those materials which can be cited.
- The resulting materials will be stored and hosted on ISCA server (http://www.isca.in)






