Response:

Experimental learning: This method of learning is the most effective way of learning. It mainly involves learning through practical experiments in the Science practical laboratories. The theories, principles, laws, various statements, concepts etc. taught in classrooms, these are prove and confirms through the experimental learning by various instruments. Teachers taught the experiments through practical's and shows the correlation of theory concept with conclusions.in the institute apart from the regular laboratory course work the department of chemistry, Botany, Zoology, Physics, Computer Science, English, Marathi, Sports Departments etc. organized various hands on experimental activities like handling of sophisticated instruments soil, water analysis training, Chem draw sketch, Plant nursery, manufacturing of Vermi composting, preparation of Nano materials, Ms Office, Communication Skills etc. and also organized exhibition's involving demonstration, training of sophisticated instruments. The other modes also used for enhancing experimental learning are mainly industrial tours, excursion filed visits, surveys, visit to research laboratories, visits to historical places arranged. The internal examination process starts with the departmental meeting conducted by the HODs. The faculty is directed by the examination committee to prepare question papers in a confidential manner. The exam timetable is displayed on the department notice board.

Practical examination and Viva Voce are conducted as per the syllabi. The marks allotted to each component are awarded based on the performance of the students in the internal tests. The teachers are informed to prepare teaching plans and asked to follow them strictly. Through the mentor-mentee program, teachers motivate students to appear for internal tests as well as university examinations. In the pandemic situation, the initiative particularly, dialogue Session was organized through an online mode. During the Lockdown in the COVID-19 period, internal tests were conducted through Google forms. Few students suffered from internet issues and other technical problems. IT committee of the college along with Grievance Redressal Committee resolved the issues related with online examination. The timetable of the internal examination is strictly followed. In Pre-COVID situation, Mobiles were not permitted in the examination room.

Vermi Composting

Objective:

Context:

Now a day's farmers are using highly toxic chemicals fertilizers due to which quality of soil becomes very worst for the agriculture crops. Due to above reasons say to say soil becomes less fertile.

Practice:

Now days the only one source to improve the soil quality is organic composting vermin composting. Whatever practices previously used by farmers are less effective because of lack of properguidance due to modern agriculture practices lack of organic waste, (Animal dung's) and availability of water. This practice is ignored by agriculturist.

Vermi composting is a unique process that occurs in earthworms out to convert organic fertilizer or vermi compost by using joint action of earthworms and micro organics likewise, connectional composting vermin composting is and aerobic process that required the presence of oxygen.

Evidence of Success:

It is the traditional method by which natural manure called vermin compost is produced from last year every month. The use of vermicompost can greatly increase the productivity of farmers. Due to vermiculture, farmers do not need to use chemical fertilizers, so the production cost of the farmer is reduced and the profit is more.

Problems:

While doing earthworm farming, farmers have difficulty in getting earthworms. An increase in temperature also affects earth worms.

Notes:

Vermiculture benefits small farmers to a great extent as farmers who cannot afford chemical fertilizers use.
